ANNUAL LETTER TO THE MEMBERSHIP

We all did our very best during the past year to elect Democrats to Congress and the Legislature. We all worked hard in campaigns, and the Board also made financial contributions to our DRC counties and Senate candidates. While all our statewide candidates were re-elected, results were very disappointing in the other arenas. In spite of extra efforts at getting out the vote, too many Democrats did not vote. In upstate New York, Republicans came out in high numbers in protest of the Safe Act. The environment was tough, but DRC Democrats do not give up; we Rebuild, Restore and Move Forward.

During the past year, we continued to respond to your issues. Some members met with staff of the Governor, State Senate Education Committee staff, Catherine Nolan, Chair of the Assembly Education Committee, several NYS Regents and Bruce Fraser of the Rural Schools Association of New York State to share our concerns about the inequity and insufficiency of funding for many rural districts in our DRC counties, and to urge for targeted increases in Foundation Aid as well as elimination of the Gap Educational Assessment We also asked you, our members, to contact your representatives in the Legislature to urge them to support our stance. We will continue our efforts in the coming year.

We surveyed you as to what training you would like to have offered at our 2015 Conference. Recognizing that 2015 is a year of local races, our training at the Conference to be offered by Karen Feldman who has helped us before, and Jim Dean, Chair of Democracy for American (DFA) will respond to your expressed needs.

We have ramped up our efforts to increase our visibility with a revitalized Facebook Page which has received well over 727 "likes." Also, a DRC brochure will be available for you at the annual Conference in April in Syracuse.

We are hoping to increase our geographical diversity on the Board during our election which will be held at the Conference. All officers and five Board seats are up for election. You will soon receive information from the Nominating Committee.

Program Book Committee – Joyce Melfi

The Program Book Committee has been diligently working to get all of the DRC County ads created, completed and finalized, along with regular supporters who have taken ads in the past. It has been moving along, but we will be heightening the pace with more follow up emails and phone calls to shore up the regular participants. That being said, it is not enough. We need you to help us get as many new ads as we can. No one knows your counties better than you do. Please sift through your contacts with unions, candidates, electeds, businesses, Democratic supporters, etc. Help us help you. To summarize, if your county ad is not yet done, please make an effort to complete it, so we can focus on other ads. Your support and assistance is greatly appreciated.

Issues Committee - Judith Hunter

Rural School funding continues to be a major focus with the Issues Committee. After meeting with The Regents, we are in favor of a "blended approach" which adds to Foundation Aid as it reduces the Gap Elimination Assessment. We again ask you to review the "White Paper" emailed to the membership a couple weeks ago and write your own Assemblyman and State Senator advocating for this change in state policy.

I-98 - Jason Clark gave a detailed update on the progress in the North Country. The DRC has been an ardent supporter of the development of the Interstate 98 corridor; a stand-alone, limited-access, four-lane highway project that would connect I-81 to I-87 across the five northernmost counties of New York State. The independent GAO projects that at least 27,000 permanent jobs would be created as a result of this long-term infrastructure investment. Interstate 98 advocates, some of whom are DRC members are pleased to report that the NYS DOT has finally scheduled a public hearing on the first leg of the project, a bypass of US 11 around Potsdam and Canton. The meeting has been scheduled for March 25 and the DOT is expected to release its final recommendations by the end of July.
